Plan Summary 2022-23

General Information

Urban Corps of San Diego County Charter School (UCCS) is a locally funded charter school, authorized by Mono County Office of Education. The overwhelming consensus of corps members when asked what they like best about the program is the ability to earn money while receiving valuable job skills training and obtaining their high school diploma.

Urban Corps of San Diego County Charter School is public school serving state and local conservation corps programs within the state of California. Our goal is to provide disenfranchised youth with a high quality and academically rigorous Common Core aligned educational program in combination with 'green' job training and community service in the fields of conservation and recycling. This unique program will provide our students with a competitive advantage in becoming employable, while protecting San Diego's natural resources and instilling the importance of community service.

Reflections: Successes

UCCS has successfully reengaged many students and increased enrollment post distance learning. During the Pandemic, the many young adults struggled with stability and academic engagement. In the 2021-2022 school year, enrollment has increased and student achievement data shows significant progress.

Reflections: Identified Need

All students are low-income and a majority of the student population are English Learners. Additionally, many have interrupted schooling and diagnostic measures show students performing below grade level. Students continue to need additional supports academically and social emotionally in order to be successful.

LCAP Highlights

A brief overview of the LCAP, including any key features that should be emphasized.

Of the students who are eligible to meet the graduation requirements, approximately 90% earn their high school diploma and either obtain gainful employment, attend community college or a combination of both. As adults, students experience a number issues that the traditional education system is not accustomed to servicing. Urban Corps Charter Schools Support Services department provides services such as counseling, case management, transportation support, and referrals to housing, food stamps, health care and a variety of community resources that support student's attendance and success in the program. All students are eligible for free breakfast and lunch through The National School Lunch Program (NSLP). To serve the unique English Learner population, the school has developed a rigorous Structured English Immersion (SEI) program to support immigrant students in obtaining academic and vocational English language proficiency. Since its inception, this program has resulted in significant advancements in English language development for this population.
